- Penalty rule was read out loud by Patty. This is Section 210 # E and states that the rule applies to all ages.

## **OLD BUSINESS:**

Karl –

Still missing 17 game scores. He will send an email out on Sunday reminding the coaches to send in their scores. All game scores should be turned in by Wednesday. A copy of this report was handed out for everyone to get an idea of how he will be tracking these scores. This is only required for 16 and 19 age groups and will be used for seating in the GYSA tournament. Teams will be given 3 points for a win and 1 point for a tie.

## **NEW BUSINESS**

U19 girls – Complaint that the WP ref was making up the rules as the game went on. The refs were following the high school rules and not GYSA rec soccer rules. The size of the goals and size of the fields were too small. Recommendation that all coaches keep the GYSA rulebook with them at all games in case they are needed to verify a call.

Donna gave Ray's report. He is doing his best to keep information on the website current. He needs proof the player sat out. This has to be documented on the game report. The \$250 fine for violent conduct is being enforced and has already been handed out to players. FYSA is backing GYSA's decision.

Game times are being changed way too frequently. All changes must be sent to Tim and Donna before changes can be made. They will either approve or deny the request for change. Both teams must first try to have an assistant (or substitute) coach cover the scheduled game time before it will be considered for a time change.

There was a complaint about the games at Largo that were cancelled. Their fields were watered after being fertilized and then it rained. They were right in canceling the games at the field for these conditions. It was not OK that the games were moved to another location without approval from Donna and Tim.

Motion was made by Melanie that game times not be changed within ten days of the scheduled game time. 2<sup>nd</sup> by Patty. Motion passed. This will be effective as of today – 11/17/08.

Donna Marie brought a guest, Bryan Bethany, requesting a player to be changed. This boy was originally registered on a U16b team, with parental consent so there were enough to make a u16 team. Due to medical reasons and with a letter from the doctor, they would like to move this boy back to U14b team. A motion was made by Gerald and 2<sup>nd</sup> by Patty. Motion passed.

Sportsmanship mentioned by Donna Marie –

Complaints were received from the coach against Gulf Coast U12b team. Score was 3 – 0 at first water break. Ref did not calling off sides. Players and parents were yelling and degrading the kids. Refs didn't do anything. Coaches ignored the behavior and allowed the teams to NOT shake hands at the end of the game.

Solution – Coach is responsible for his players and this will be addressed by the club.

Referee should find a club board member and have them address the issue with the parents.

Ref should stop the players and notify the coach that if the behavior doesn't stop they'll be carded.

Have a copy of the first page of the Coaches book and have ready to hand out.

GYSA T-shirt drawings will be voted on at the Christmas party. This will be held Sunday, December 14<sup>th</sup> @ Tio Pepe's on Gulf to Bay. Confirmation email will come out this week.
